## SUBJECT: AB 1159: SHARING RESPONSIBILITY FOR ALKALINE BATTERY AND NEEDLE MANAGEMENT - SUPPORT

Dear Chairperson Gomez:

The California Recycling and Resource Recovery Association (CRRA) supports AB 1159, which would create a Product Stewardship Pilot Program and would require producers of home-generated sharps waste or household batteries to develop a stewardship plan. The majority of our members are local governments and the companies that support local governments in their materials management programs.

AB 1159 is a pilot-program that seeks to demonstrate the effectiveness and potential application of Extended Producer Responsibility (EPR) programs. It will require producers of household batteries and sharps to design, implement and manage customized collection systems that are safe and convenient for California consumers to use for recycling and disposal.

AB 1159 does not require manufacturers to bear the full responsibility for the impact of these products – but it does require a contribution to the efforts already funded by taxpayers and managed by local governments. AB 1159 recognizes that industry has a role in managing the end-of-life consequences for products they produce that have substantial societal impacts.

We are also in strong support of this important legislation for these additional reasons:

 Our members incur significant cost and risk associated with managing these products and trying to prevent them from entering landfills where they pose environmental hazards.





- Needle stick injuries resulting from inappropriate management of sharps are
  of great concern to CRRA members because of the undue health risk to public
  and private sector employees engaged in the handling of materials.
- The Pilot Program allows us to test the efficacy of a more convenient approach which may significantly improve the recovery rate for these dangerous products while reducing cost to local government and risk to worker's health and safety.
